

**Warranty**

**BIG R BRIDGE<sup>®</sup> Rolled Girder Steel Structures**

Contech Engineered Solutions LLC (“Contech”) warrants, at the time of delivery, that it has conveyed good title to its steel structure(s), free of liens and encumbrances created by Contech, and that its steel structure(s) are free of defects in design, material and workmanship. This warranty is valid for a period of one (1) year from the earlier date of delivery or 60 days after final fabrication is complete. Durable hardwood decking and hardwood attachments shall carry a one (1) year warranty against rot, termite damage, or fungal decay. This warranty specifically excludes all softwood and decking material such as Treated Southern Yellow Pine, Douglas Fir and Wood thermoplastic composite lumber (e.g. Trex). Paint, galvanizing and other special coatings, if warranted, shall be warranted by the coating manufacturer in accordance with their warranty provisions and are not covered under this warranty.

This warranty shall not cover defects in any steel structure(s) caused by abuse, misuse, overloading, accident, improper installation, maintenance, alteration, or any other cause not expressly warranted. This warranty does not cover damage resulting from or relating to the use of any kind of de-icing material. This warranty shall be void unless owner's records are supplied that show compliance with the minimum guidelines specified in the “Recommendations for the Inspection and Maintenance of CONTINENTAL Pedestrian Truss Steel Structures, STEADFAST Vehicular Truss Steel Structures, EXPRESS Continental Pedestrian Truss Steel Structures and Big R Bridge Rolled Girder Steel Structures” attached hereto and incorporated herein by this reference.

Repair, replacement, or adjustment, in Contech’s sole discretion, shall be the exclusive remedy for any defects under this warranty. **THIS WARRANTY EXCLUDES LIABILITY FOR ANY INDIRECT, CONSEQUENTIAL, OR INCIDENTAL DAMAGES.**
